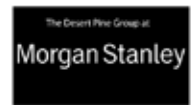

Hunter championships will be presented in each hunter section with the top four over fences earning under saddle points. Equitation championships will be presented in each equitation section with points counting equally for all classes. Combined section championships will be presented in each combined section with points counting equally for all classes. Ties broken by the most points over fences; if still tied, then most points in the equitation flat class.

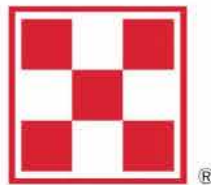

## RULES, REGULATIONS AND GENERAL INFORMATION

These competitions are governed and approved by the United States Equestrian Federation. Every class offered herein which is covered by the rules and specifications of the current USEF Rule Book will be conducted and judged in accordance therewith. To the extent there is a conflict between the prize list and the USEF rules, USEF rules will prevail. Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes

REMINDER: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. **CONDITIONS OF ENTRY:** Every horse entered for competition will be under the control of the Horse Show Management, but Horse Show Management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall defend, indemnify and hold harmless the Horse Show and its officials, employees, directors, officers, J Bar J Youth and its Sponsors, etc for any loss or accident to his horse, horses, employees or equipment which may occur from sickness, fire or other cause.

**MANAGEMENT:** Horse Show Management reserves the right to interpret all questions and conditions in regard to or arising out of an incident to the show without claims for damages or recourse of any kind. All questions not covered in these Rules and Regulations shall be decided by Horse Show Management-their decision to be final. Horse Show Management reserves the right to refuse, accept conditionally or to cancel any entries, disqualify riders or exhibitors, prohibit exhibition of entries and cancel award prizes, without claim for damages; to change any course, to cancel or combine any unfilled classes, or to reschedule classes, after due notice to exhibitors; to change rings or rotate or change judges and officials; to change specifications in jumper classes in order to facilitate the time schedule. Management reserves the right to combine or cancel. Management reserves the right to limit entries in a class. Refused entries will be returned.

**ASSUMPTION OF RISK:** By signing the entry blank, the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Loungeur acknowledges that horseback riding, particularly jumping, is a dangerous activity and involves inherent risks that may cause serious injury and in some cases death because of the unpredictable nature and irrational behavior of horses, regardless of their training and past performance and expressly assumes all such inherent risks whether identified herein, in the entry blank, or in the Federation Rules and Regulations. A horse, without warning or any apparent cause, can buck, stumble, fall, rear, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on a person's foot or push a person-all of which may cause the rider or observer to fall or be jolted, resulting in serious injury or death. A horse may also become loose and cause injury to an observer or rider or to another horse-a loose horse can run at full gallop in a panic and run into objects or persons or other horses. The Show Ground Facilities are bordered by highways/roads and thus noise from traffic and other sources occurs that can and will cause a horse to unexpectedly spook or react quickly. The Show Ground Facilities contain roads or driveways that are traversed by cars, golf carts, tractors, trailers and heavy equipment all of which may spook a horse. The above warnings and risks are meant as an example of some of the risks that are inherent and may be encountered but it is agreed this is not an exhaustive list and there are numerous additional conditions and/or events that may result in injuries while participating in the Competition and/or being present on the Show Ground Facility.

**DAMAGE:** Owners and exhibitors shall be held responsible for damage caused by them, their agents or employees to stalls, buildings and other properties on the show grounds, and shall be billed accordingly.

**ADHERENCE TO THE RULES:** All individuals on the property are required to adhere to the rules mentioned in the prize list or as directed by the employees at the horse park. Trainers are all responsible for employees adhering to the rules. Violations will result in expulsion from the facility.

**CLOSING OF ENTRIES:** Entries close June 15, 2026

**ENTRY PROCEDURES:** Exhibitors may pay either by check or credit card (Visa or Mastercard). Exhibitors must enter online through [showgroundslive.com](http://showgroundslive.com).

Trainers and owners must leave a signed open check or credit card authorization for charges during the shows. Any accounts not closed each week will be charged \$100.

**TRAINER SPLITS:** OHDC allows trainers to split the show charges for miscellaneous items to their clients. Splits will be accepted until noon on the Friday of a show week. No exceptions will be made. Only items billed by the horse show directly can be split. Splits will revert back to the trainer for payment if uncollected.

ALL ENTRIES WHICH ARE LATE WILL BE ASSESSED A \$100 LATE FEE.

Exhibitors will receive their prize money within 30 days after the Horse Show.

**CREDIT CARDS:** Exhibitors wishing to pay by credit card will be charged a 3% convenience fee. This fee is non refundable after the card has been charged.

**USHJA HORSE REGISTRATIONS:** All horses competing in Federation non-breed restricted licensed competitions with hunter, hunter breeding, jumper and hunter seat equitation classes (except those activities enumerated in GR901.9, items 1-11) must be properly identified and must obtain a Registration Number from USHJA. A registration number for each horse must be entered on all entry forms for licensed competitions.

**CANADIAN EXHIBITORS:** Entries must be paid by draft payable in US Funds or check on Canadian US Dollar account. Canadian checks with US Funds written on the face of the check will not be accepted.

Nomination 3: Horses entered in any 1.20m or higher jumper class : \$150

**CANCELLATION OF ENTRIES AND REFUNDS:** Exhibitors canceling entries after the closing

date shall forfeit their stall fee and the scratch fee of \$50.00. Credit card processing fees are non refundable once the card has been refunded. Refunds will be mailed within three weeks after the Horse Show.

**RETURNED CHECKS/CREDIT CARDS:** There will be a penalty of \$75 per check/credit card returned by the bank for any reason. No checks/credit cards will be processed through the bank a second time. To retain entries, the fees and penalty must be paid by Money Order, Cashiers Check or Cash before 4 PM the day before the Horse Show starts. In the event a check/credit card is returned after the completion of the show, it will be handled in accordance with USEF GR913. No personal checks will be cashed at the Show. Please plan accordingly.

**USEF FEE:** For every horse participating in any competition recognized by the USEF, a \$25 USEF fee will be collected (\$15 shall be a Drugs & Medication fee to provide for research, inspection and enforcement of rules regarding use of medications and drugs; see GR407.1, .2 and .3.

**USHJA SUPPORT FEE:** Every horse entered in any competition recognized by the USEF will be assessed a \$10.00 USHJA Support Fee. Outreach participants will be assessed a \$5.00 USHJA Outreach Fee.

Curfew and quiet times must be observed between 9pm and 5am (as required by GR1215.3 #033-22)

**HORSE IDENTIFICATION:** Horses are now required to have a back number attached to their neck or their rider when outside of their barn/tent (as per HJ106.2 #247-22).

**NON SHOWING HORSES:** NO NON SHOWING HORSES ACCEPTED. ALL HORSES/PONIES MUST COMPETE AT THE HORSE SHOW unless there are stalls available.

**MEASUREMENT AND AMATEUR CERTIFICATION:** All Small, Junior and Pony Hunters must possess and present a current Measurement Card to the show secretary before numbers may be picked up. If the cards are not available, MEASUREMENT WILL BE REQUIRED. Photocopies of current Amateur Certification of Junior Memberships may be included with entries or made available when picking up numbers. **MANAGEMENT:** Management reserves the right to cancel or combine any classes that do not fill to their satisfaction. Equitation classes not filling may be combined with the next age group. Notice will be given to exhibitors affected. Management reserves the right to start the first class of any session 30 minutes earlier than the scheduled time if entries warrant. Management reserves the right to make changes of arenas, judges, or class orders to facilitate time schedule and conditions.

**COMBINED CLASSES & SECTIONS:** Any class or section that does not have at least five entries 12 hours before the first class is scheduled (unless otherwise specified) will be combined.

**TROPHIES, RIBBONS, PRIZE MONEY:** Trophy and ribbons will be awarded to eight places in all Hunter, Equitation and Junior classes. Hunter prize money will be divided 30%, 25%, 20%, 15%, 10%. Jumper prize money will be divided 25%, 23%, 20%, 17%, 15%. Grand Prix prize money

STABLING: Portable box stalls with doors on grass/dirt are provided. Shavings may be purchased. Stalls will be available for occupancy at 10:00 a.m. Sunday morning July 5 must be vacated Sunday, day July 12 unless otherwise arranged with show management. Fee for box stalls for each show shall be \$400 Exhibitors do their own stall cleaning. Refunds after those dates will only be made if the stall is reissued to another entry by management.

SHAVINGS & MANURE DISPOSAL FEE: There will be a \$60 per horse shavings & manure disposal fee.

SCHOOLING AND EXERCISE: unJudged warm ups on Tuesday (hunter rings and jumper 1)

MOTORIZED VEHICLES: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device

in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**HAUL-INS:** Haul ins will be allowed with management approval.

**3RV PARKING:** Electricity and water will be provided on a first come first serve basis (limit of 35) for a fee of \$500.00 per week. Please send in RV Form (on website).

**FOOTING:** Competition rings are grass. Warm-up areas are grass and all weather footing. Hunter & Jumper Rings are 300 X 150, Grand Prix ring is 320 X 300.

**DRESS:** It is compulsory for all persons at Federation licensed hunter, jumper or hunter/jumper competitions, when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials) / (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. It is compulsory for rider in Paso Fino classes, both open and breed restricted including Hunter Hack, where jumping is required and when jumping anywhere on the competition grounds to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials) / (SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. A Show Committee must bar riders without protective headgear from entering the ring for classes in which protective headgear is required and may bar any entry or person from entering the ring if not suitably presented to appear before an audience.

Competition management may fine any individuals including trainers, owners, exhibitors, or their agent up to \$100 for improper disposal of needles or other sharp disposable instruments.

**RINGSIDE TENTS:** Tents may be put at ringside for \$300. Please check with management for placement.

**TIES:** In all jumper classes, ties involving first place will be jumped off. All other ties will be determined by time taken to complete the first round.

**MICROCHIP VERIFICATION:** All horses competing in classes that require USHJA horse registration must provide a microchip number that verifies their animal's identity in order to compete for points, money won or be eligible for Federation and/or USHJA programs and awards where horses are required to be recorded or registered. A microchip used to verify identity must be a fifteen-digit ISO compliant 11784/11785 chip and be implanted in the nuchal ligament of the animal. All horses that are competing in classes which require USHJA registration which are not microchipped will be ineligible to compete in Federation licensed competitions, Exceptions: USHJA Outreach and those activities enumerated in GR901.9, items 1-9.

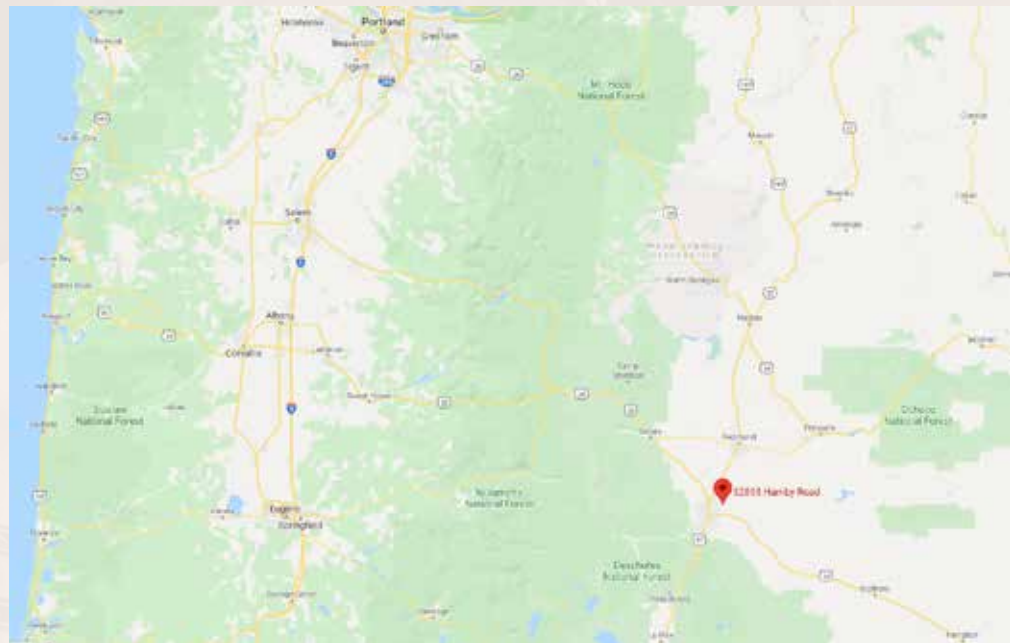
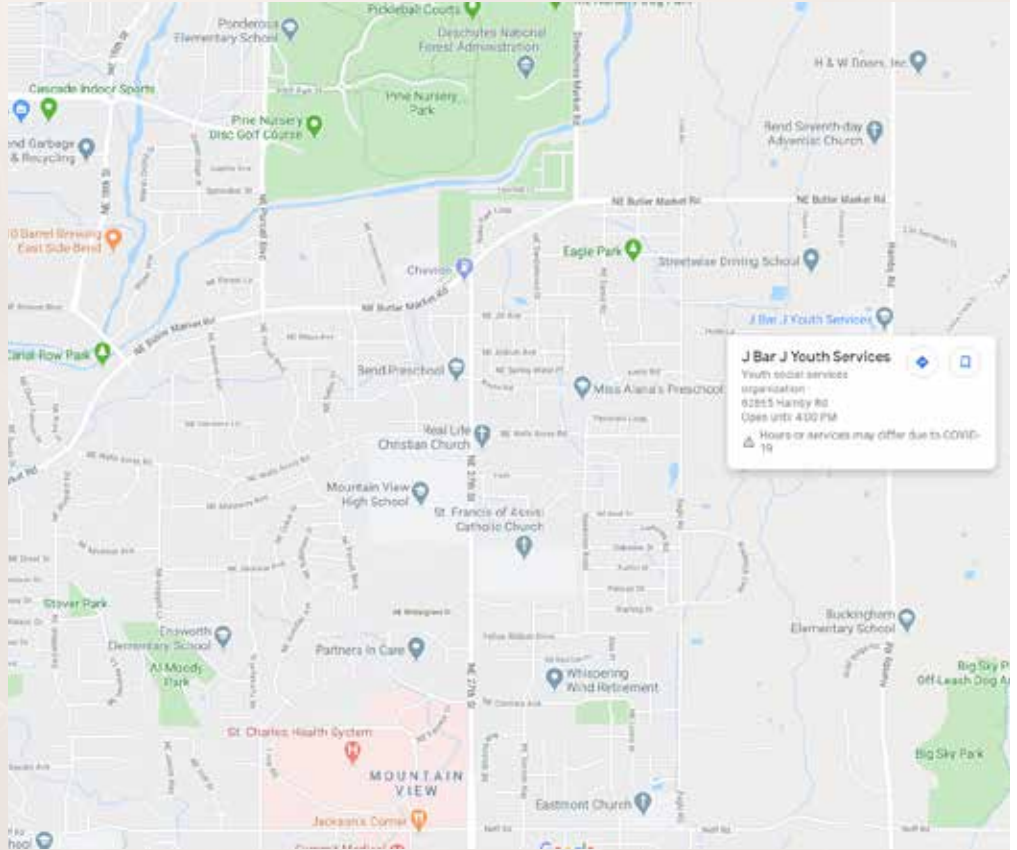

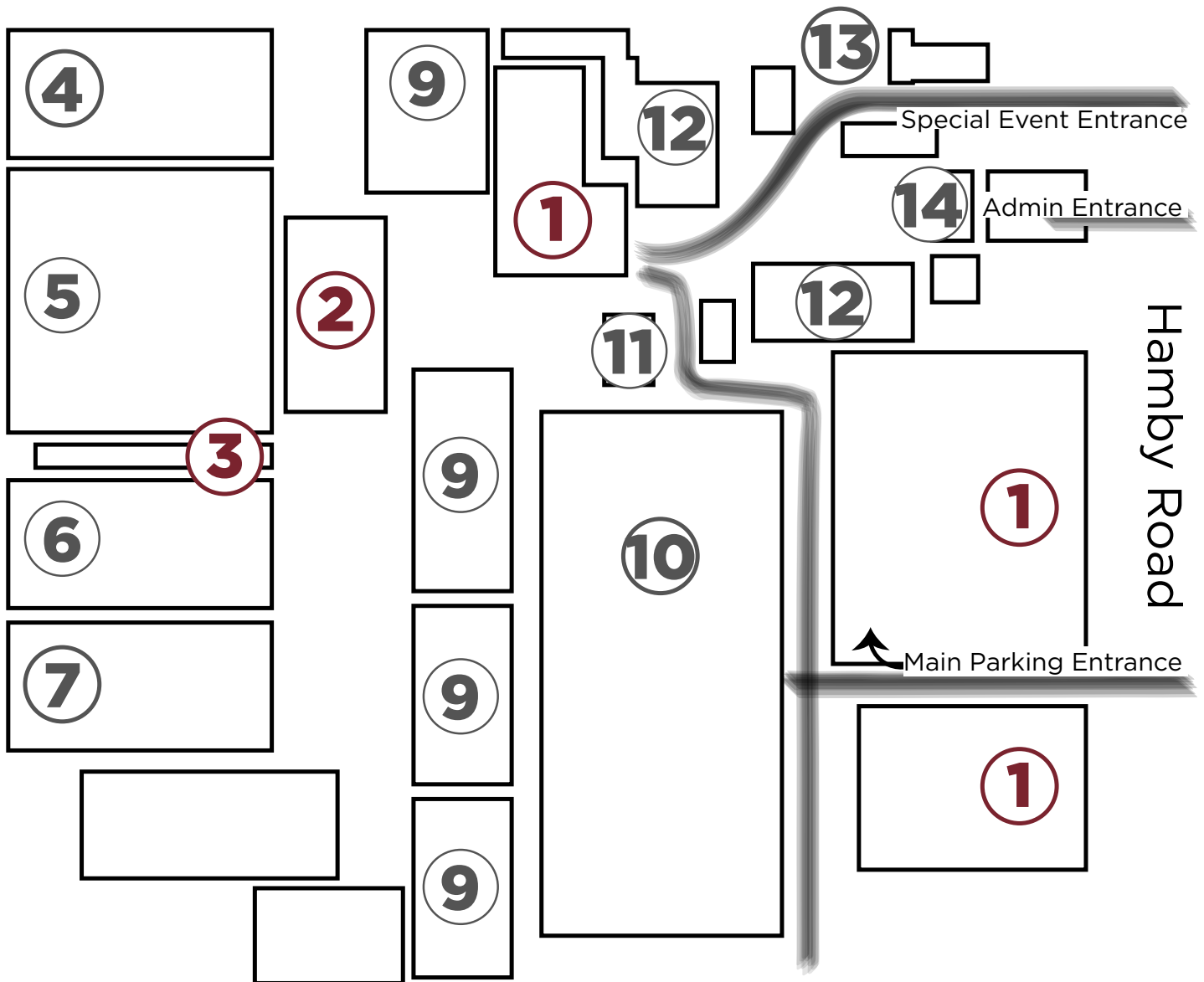
